

Subject:- State wise allocation of funds (Central share) under National Bamboo Mission(NBM) for the year 2020-21 and preparation of Annual Action Plan for implementation of (NBM)- reg

Sir/Madam,

The Annual allocation of funds (Central share) to the States for implementation of NBM for the year 2020-21 is hereby enclosed at Annexure I. It is requested that Annual Action Plan (AAP) for the year (2020-21) based on Central and corresponding State share under NBM may be prepared as per the operational guidelines of NBM and after due approval of State Level Executive Committee(SLEC) be submitted for further processing and release of fund. The spill over works of the previous year approved AAP must be included (separately) in the AAP of 2020-21 and its implementation to be done using the allocated fund only. The pattern of assistance between Centre and States is in the ratio of 90:10 for North Eastern and Himalayan States and 60:40 for all other States. For UTs, the assistance will be 100 % from Gol.

Release of funds would only be processed after the receipt of utilization of the allocated funds with matching State share (UCs) & detailed progress report (including soft copy, photographs/ video, location of the nurseries and plantation created during the year, training imparted and beneficiaries, number of species wise saplings/ seedling in the nurseries etc.) against the funds already released to the respective State during previous years. At present, release shall be need based giving due importance to plantation.
